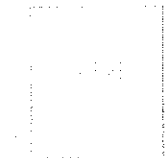

## AFFIDAVIT of PROBABLE CAUSE

\*  
On 10-23-2007, CI#4108-06 contacted Sergeant McTigue and Affiant stating that he was able to buy cocaine from Janet Alberts and/or Dora Sponsler. The CI had been in contact with Sponsler who was at Alberts' residence at 1417 Washington Avenue 1st floor, waiting for him to come to buy the cocaine. The CI met with Affiant at the Altoona City Police Department. The CI did not have to call ahead because they were expecting him.

On 10-23-2007, at 2335 hrs, the CI was strip searched by Affiant for drugs and/or money with negative results. The CI was given \$100 in recorded task force funds and instructed to purchase \$100 of cocaine from either Alberts or Sponsler. Patrolman Sapienza and Patrolman Wright maintained stationary surveillance of 1417 Washington Avenue.

On 10-24-2007, at 0021 hrs, Affiant transported the CI to the 1400 block of Washington Avenue. At 0022 hrs, the CI entered 1417 Washington Avenue, 1st floor and made contact with Alberts. Alberts told the CI that Sponsler had to go and said that she would send Jeff Sponsler to pick up the cocaine. The CI handed Alberts the \$100 in recorded task force funds and waited in the living room. Alberts went into the kitchen and returned to wait with the CI. At 0035 hrs, Patrolman Sapienza and Patrolman Wright observed a white male (Jeff Sponsler) leave 1417 Washington Avenue and walk west in the alley. At 0048 hrs, the same white male returned on foot from the alley and entered the residence. At 0058 hrs, the CI exited the residence, walked to Affiant's vehicle and handed over a clear baggie of a white powder substance.

The CI was transported to the Altoona City Police Department. At 0110 hrs, the CI was strip searched by Patrolman Sapienza for drugs and/or money with negative results. The CI then provided a written statement with regard to the transaction. The CI stated that when Jeff Sponsler returned, Alberts came out of the kitchen and handed him the baggie of powder cocaine. The CI stated that Sponsler parks his vehicle adjacent to the Jewish Memorial Center, which is consistent with the direction he walked after leaving and then returning to the residence.

At 0125 hrs, Affiant field-tested a portion of the baggie of the white, powder substance utilizing a N.I.K. testing kit (Test G). The test yielded a positive reaction for the presence of cocaine. The baggie was re-sealed, packaged as evidence, verified by Affiant and Patrolman Wright, and accompanied with a laboratory analysis form to be sent to Greensburg PSP Crime lab for chemical testing. The evidence was placed into the slotted evidence locker for the evidence custodian.
