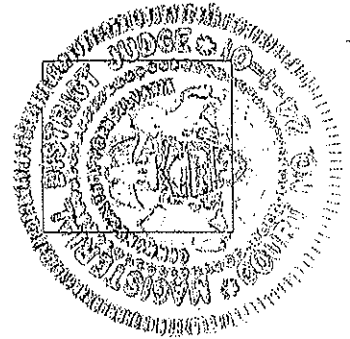

AFFIDAVIT of PROBABLE CAUSE

On 11-16-2008, CI#4203-08 contacted Affiant, Sgt. T. Johannides, to advise that she could purchase heroin from Deborah Scott of 430 Willow Avenue. Scott advised the CI she would sell her one bundle of heroin for \$175.

At 1415 hrs, the CI was strip searched by Patrolman Shaffer for drugs and/or money with negative results. Affiant provided the CI with \$175 in recorded task force funds.

At 1434 hrs, in the presence of Affiant, the CI called Scott on her cellular telephone to make sure Scott was home to buy the heroin. Scott told the CI she was home and to stop over.

At 1438 hrs, the CI got out of Affiant's vehicle on 5th Street and walked to 430 Willow Avenue. Patrolman Crist was on surveillance and observed the CI enter the residence. When the CI entered, the CI's cellular telephone rang and Scott told the CI to come upstairs to the third floor.

The CI entered Scott's third floor bedroom and handed Scott the \$175 in recorded task force funds. Scott took a bundle of heroin from inside a red silk bag with black velvet design. Scott opened the bundle, counted that it had (10) packets, put the rubber band back on and handed it to the CI.

At 1445 hrs, the CI exited 430 Willow Avenue and walked to Affiant's vehicle. The CI immediately handed Affiant a bundle of suspected heroin containing (10) white wax packets of off-white powder substance marked "711" in red letters.

At 1500 hrs, Affiant, in the presence of Patrolman Crist, field-tested one of the ten white wax packets of off-white powder using a N.I.K testing kit (Test A) and obtained a positive reaction for the presence of heroin. The open packet was re-sealed and all ten packets were placed into a large manila envelope, marked for identification, sealed and verified by Affiant and Patrolman Crist, and placed into the slotted evidence locker for the custodian. A laboratory analysis form was compiled for the item to be sent to the Greensburg PSP Crime Lab for chemical testing.

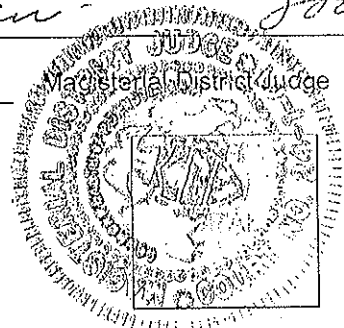
At 1530 hrs, the CI was strip searched by Patrolman Shaffer for drugs and/or money with negative results. The CI provided a written statement with regard to the above incident.

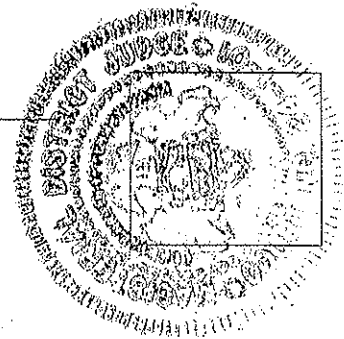

Johannides, advising that Deborah Scott was having heroin dropped off at Scott's residence (430 Willow Avenue) from Scott's supplier, Biz, an unknown black male. Scott advised the CI that she missed Biz while she was not home and wanted the CI to wait at her house for Biz to arrive.

At 1211 hrs, Scott picked up the CI and dropped her off at 430 Willow Avenue. At 1220 hrs, the CI called Affiant and confirmed that she was the only person inside the residence at the time. At 1242 hrs, the CI called Affiant and advised that Biz had arrived. Officers observed Scott, her child, and Biz enter the residence.

Once inside, Biz handed Scott (2) bricks of heroin. Biz and Scott spoke about Scott owing Biz \$1000 for the fronted heroin, consistent with \$10 a packet, which Scott advised the CI she paid Biz. Scott would then sell the heroin for \$25 a packet. Biz then left the residence on foot.

The CI and Scott walked upstairs to the third floor of the residence where Scott used (4) bags of heroin for herself and gave another person (6) bags to sell. The CI observed Scott put all the heroin fronted to her from Biz into a red, silk bag with black velvet design and place it into her nightstand.

At 1313 hrs, the CI called Affiant to ask if I still wanted to buy a bundle. Affiant told the CI I would be ready in 45 minutes. The CI stated she would be waiting at her residence. At 1320 hrs, the CI advised Affiant that she was waiting at her residence. The CI was then picked up by Affiant and transported to the Altoona City Police Department. The CI provided a written statement with regard to the above incident.

At 1434 hrs, the CI called Scott to see if she was home to make a purchase of a bundle of heroin as prearranged. The CI was strip-searched prior to and after the controlled buy. The CI purchased (10) white, wax packets of an off-white powder substance, stamped '711' in red with \$175 in recorded task force funds. The CI advised Scott obtained the heroin from the red, silk bag with black velvet design.

At 1500 hrs, Affiant, in the presence of Patrolman Crist, field tested one of the ten baggies bought during the controlled buy utilizing a N.I.K. testing kit (Test A) and obtained a positive reaction for the presence of heroin. All ten baggies were packaged as evidence and sent to the Greensburg PSP crime lab for chemical testing. The CI provided a written statement with further details on the controlled buy.

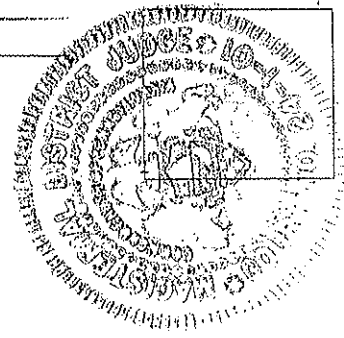

On 11-17-2008, Deborah Jean Scott advised CI#4203-08 that she would be out of town the next day and to contact her daughter, Harli Mae Yednak, at Scott's residence if the CI needed to buy heroin. Scott sold a bundle of heroin to the CI on a previous controlled buy for \$175.

On 11-18-2008, Affiant, Sgt. T. Johannides, picked up the CI and transported her to the Altoona City Police Department.

At 1645 hrs, the CI was strip searched by Detective Hogan for drugs and/or money with negative results. Affiant provided the CI with \$175 in recorded task force funds and instructed her to purchase a bundle of heroin from Yednak.

At 1707 hrs, in the presence of Affiant, the CI called Deborah Scott's home telephone number and Harli Yednak answered the telephone. The CI asked to buy a bundle and Yednak told her to come to the house but that someone else was coming to buy the rest of the heroin Yednak was holding. The CI told Yednak she would be right there.

At 1708 hrs, the CI got out of Affiant's vehicle on 5th Street and walked into the rear door of 430 Willow Avenue. Patrolman Crist was on surveillance and observed the CI enter the back porch of the residence.

Inside, the CI walked upstairs and met with Harli Yednak on the third floor in Deborah Scott's bedroom. The CI asked Yednak for a bundle of heroin. Yednak called Scott on her cellular telephone to make sure what price to charge and Scott told Yednak \$175. Yednak retrieved Scott's red silk bag with black velvet design and dumped it onto the bed. Yednak counted one bundle and it only had nine packets. Yednak took one packet from the other bundle, placed a rubber band around the ten packets and handed it to the CI. The CI then handed Yednak the \$175 in recorded task force funds.

At 1716 hrs, Affiant observed the CI exit the rear door of 430 Willow Avenue and walk to Affiant's vehicle. The CI immediately handed Affiant a bundle of suspected heroin containing (10) white wax packets of off-white powder substance marked "711" in red letters.

At 1740 hrs, Affiant, in the presence of Patrolman Crist, field-tested one of the ten white wax packets of off-white powder using a N.I.K testing kit (Test A) and obtained a positive reaction for the presence of heroin. The open packet was re-sealed and all ten packets were placed into a large manila envelope, marked for identification, sealed and verified by Affiant and Patrolman Crist, and placed into the slotted evidence locker for the custodian. A laboratory analysis form was compiled for the item to be sent to the Greensburg PSP Crime Lab for chemical testing.

At 1830 hrs, the CI was strip searched by Officer Stamm of the PSU Police Department for drugs and/or money with negative results. The CI provided a written statement with regard to the above incident.

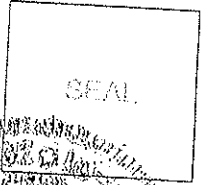

On 11-20-2008, Deborah Scott and her husband Tristan drove CI#4203-08 to and from the methadone clinic. When Deborah Scott dropped the CI off, Scott told the CI to call her if she needed any heroin. The CI contacted Affiant regarding the information, was picked up, and transported her to the Altoona City Police Department.

At 1147 hrs, the CI was strip searched by Civilian Boling for drugs and/or money with negative results. Affiant provided the CI with \$175 in recorded task force funds and instructed her to purchase a bundle of heroin from Deborah Scott.

Patrolman Crist set up surveillance to view the front of Deborah Scott's residence at 430 Willow Avenue.

At 1237 hrs, in the presence of Affiant, the CI called Deborah Scott's cellular telephone number () and Deborah answered the telephone. The CI asked if she was home and if it was all right to stop by. Deborah Scott told the CI she was home and to come by the residence.

At 1240 hrs, the CI got out of Affiant's vehicle on 5th Street and walked into the front door of 430 Willow Avenue. Patrolman Crist observed the CI enter the residence.

When the CI walked into the residence, Deborah Scott was at the top of the steps and told the CI to walk upstairs with her. The CI and Deborah Scott walked to the third floor bedroom where Tristan Scott was sitting on the bed. Deborah Scott picked up her red silk bag with black velvet design and pulled out a bundle of heroin. The CI handed Deborah Scott the bundle of heroin and the CI asked if there were (10) bags there because Deborah Scott did not count it as she had previously. Deborah Scott told her yes and the CI handed Deborah Scott the \$175 in recorded task force funds. The CI and Scott engaged in casual conversation and then the CI walked downstairs.

At 1246 hrs, CI exited the front door of 430 Willow Avenue (observed by Patrolman Crist) and walk to Affiant's vehicle. The CI immediately handed Affiant a bundle of suspected heroin containing (10) white wax packets of off-white powder substance marked "711" in red letters.

At 1305 hrs, Affiant, in the presence of Patrolman Crist, field-tested one of the ten white wax packets of off-white powder using a N.I.K testing kit (Test A) and obtained a positive reaction for the presence of heroin. The open packet was re-sealed and all ten packets were placed into a large manila envelope, marked for identification, sealed and verified by Affiant and Patrolman Crist, and placed into the slotted evidence locker for the custodian. A laboratory analysis form was compiled for the item to be sent to the Greensburg PSP Crime Lab for chemical testing.

At 1305 hrs, the CI was strip searched by Civilian Boling for drugs and/or money with negative results. The CI provided a written statement with regard to the above incident.
